PVCu Coating Guarantee

We hereby guarantee that the coating applied to an approved substrate (PVCu surface or profile) will, subject to the provisions of the guarantee, have the following properties guaranteed for a period of 10 years on adhesion and 5 years on all other matters, from the date of the factory finished product leaving our premises.

The coated product should have the following properties:

1. Degree of Gloss.

At the time of application, the degree of gloss will vary according to that specified. Any gloss reduction will occur evenly over the surface without adversely affecting the appearance. BS3900 1980 part D5/ISO2813 1994.

2. Weather Resistance

To RAL-RG 716/1, Section I, part 6, poss.3.2.5 Radiation 8000 MJ/m² approximately 4000 hours duration and corresponding to "Grey Scale" 3 or greater measured according to DIN 54001. Colours in range 1<3 in SKZ listing must have a clear top coat.

This guarantee shall be subject to the following conditions:

1 The coated product must be used in a normal environment, not Marine, Industrial or Swimming Pool environment.

2. The coating must be cleaned when it becomes soiled.

(i) The cleaning interval should be determined by the amount of soiling and not exceed six months on a normal environment.

(ii) Cleaning should commence at the date of installation using a mild detergent and warm water on all surfaces and a soft cloth or sponge but nothing harsher than a natural bristle brush, followed by fresh water rinsing.

(iii) Fully documented and corroborative records of the cleaning must be kept, for the period of the guarantee by the client of the building to which the guarantee relates, stating the date, contractor and cleaning materials used.

If touch up materials are used the areas coated in these materials are expressly excluded from the guarantee.

Our product is made invalid by any change to the product.

A claim may not be made on the basis of

1. Act of God

2. Mechanical Abrasion

3. Weathering or other influences in excess of normal natural conditions whether known, unknown or not anticipated at the time of issue of this guarantee.

Excluded from this guarantee is damage caused by failure of the substrate and/or due to element dimensions and/or colour (dark colours), causing excessive contraction, expansion or softening under extreme temperature conditions.

The guarantee starts from the application date of the coating and in the event of the guarantee being called will not be extended beyond the initial guarantee period. Following expiry no further claims can be made against the manufacturer.

The court of legal jurisdiction is England.

Note: All claims should be made in writing to Whiteline Manufacturing Ltd within 14 days of the defect first appearing.

Note: The extent of the liability of this guarantee is limited to the replacement of the product.

Note: The statutory rights of consumers are not affected and is non transferable.

Note: This warranty does not cover damage caused by vandalism, misuse or wear and tear
